



We Came to Play Trip Contest Official Contest Rules

These rules apply to the We Came to Play Trip Contest (“Contest”) conducted by Beasley Media Group, LLC d/b/a WBAV-FM (“Station”). **In addition, the General Contest Rules posted at www.v1019.com apply to this Contest. If there is a conflict between the General Contest Rules and the Rules for this Contest, the Rules for this Contest shall control.**

1. HOW TO ENTER

- a. The Contest will begin on Monday, March 3, 2025 and end on Sunday, April 6, 2025.
- b. To enter online, visit www.v1019.com and follow the links and instructions to enter the Contest and complete and submit the online entry form beginning on Monday, March 3, 2025 at 12:00 am Eastern Time (“ET”) and ending at 11:59pm ET on Sunday, April 6, 2025 (“Online Entry Period”). Online entrants are subject to all notices posted online including but not limited to the Station's Privacy Policy. Limit one (1) entry per eligible person per day during the Online Entry Period regardless if entrant has more than one email address. Multiple entrants are not permitted to share the same email address. Entries submitted may not be acknowledged or returned. Proof of submission of an entry shall not be deemed proof of receipt by the Contest administrator.
- c. There will be up to a total of one (1) winner selected in the Contest.

2. ELIGIBILITY RESTRICTIONS

- a. This Contest is open to all Station listeners who are 18 years of age or older as of the date of entry into the Contest, who are legal US residents and reside in North or South Carolina, except where prohibited by law. Winners must possess a valid, government-issued ID and show proof of residency to verify eligibility.

3. PRIZES

- a. Up to one (1) Prize will be awarded. The Prize is being provided by Walt Disney World and consists of a five day/four night Walt Disney World® Resort vacation for four (4), Four (4) round trip coach airfares between the major gateway airport closest to traveler's residence and the Orlando International Airport, One (1) round trip ground transfers between the Orlando International Airport and the Walt Disney World® Resort, one (1) standard room(s) (with a maximum of four (4) persons per room) for four (4) night(s) at a hotel at the Walt Disney World® Resort selected by Disney in its sole discretion; based on availability, and Four (4) 5-day Theme Park Tickets with Park Hopper® Option and a \$300 Disney Gift Card. Total approximate retail value of prize: \$8,600.60.

NOTE: Items that are not included as part of the winning vacation package(s) are: meals, hotel room service, laundry service, alcoholic beverages, merchandise, souvenirs, etc., local and long distance telephone calls, tips, gratuities, service charges or taxes. Reservations are subject to availability and are not guaranteed until a reservation is finalized. A park reservation must be made for each day of entry.

Actual value may vary and any difference between stated value and actual value will not be awarded. Certain travel restrictions may apply. All other costs not specifically stated herein, including but not limited to those of, taxes, meals, tips and additional ground transportation, baggage fees, hotel room service, laundry service, alcoholic beverages, merchandise, souvenirs, and local and long-distance telephone calls are the responsibility of the winner. Selection of airline, hotel, and airline seat location at sole discretion of Station and/or prize provider. Airline regulations apply. The winner and guest must travel on the same itinerary and are responsible for obtaining all required travel documents, including, without

- c. Entrants need not listen to the Station or be present to win.
- d. Winner must confirm acceptance of prize within forty-eight (48) hours of winning, or risk disqualification and selection of an alternate winner (time permitting) in a random drawing of all remaining eligible entries.
