**Walt Disney World Trip Giveaway**  
**Official Contest Rules**

These rules apply to the Disney First Timer Giveaway Contest (“Contest”) conducted by Beasley Media Group, LLC d/b/a WBAV-FM (“Station”). In addition, the General Contest Rules posted at [www.v1019.com](http://www.v1019.com) apply to this Contest. If there is a conflict between the General Contest Rules and the Rules for this Contest, the Rules for this Contest shall control.

**1. HOW TO ENTER**

- a. The Contest will begin on Tuesday, September 6, 2022 and end on Friday, September 30, 2022.
- b. To participate in the Contest, visit [www.v1019.com](http://www.v1019.com) and follow the links and instructions to enter the Contest and complete and submit the online entry form beginning on Tuesday, September 6, 2022 at 12:00:01 AM Eastern Time (“ET”) and ending on Friday, September 30, 2022 at 11:59:59 PM ET (“Online Entry Period”). Online entrants are subject to all notices posted online including but not limited to the Station's Privacy Policy. Limit one (1) entry per eligible person during the Online Entry Period regardless if entrant has more than one email address. Multiple entrants are not permitted to share the same email address. Entries submitted may not be acknowledged or returned. Proof of submission of an entry shall not be deemed proof of receipt by the Contest administrator.
- c. There will be up to a total of one (1) winner selected in the Contest.

**2. ELIGIBILITY RESTRICTIONS**

- a. This Contest is open to all Station listeners who are 18 years of age or older as of the date of entry into the Contest, who are legal US residents and reside in North or South Carolina, except where prohibited by law. Winners must possess a valid, government-issued ID and show proof of residency to verify eligibility.

**3. PRIZES**

- a. Up to one (1) Prize will be awarded in the Contest. The Prize is being provided by WALT DISNEY WORLD® RESORT and consists one (1) vacation package for four (4) persons for four (4) nights and five (5) days at the Walt Disney World® Resort. Trip includes:
  - i. Four (4) round trip coach airfares between the major gateway airport closest to traveler's residence and the Orlando International Airport.
  - ii. One (1) round trip ground transfers between the Orlando International Airport and

- the Walt Disney World® Resort via limousine or SUV.
- iii. Room accommodations consisting of one (1) standard room(s) (with a maximum of four (4) persons per room) for four (4) night(s) at a hotel at the Walt Disney World® Resort selected by Disney in its sole discretion; based on availability.
  - iv. Four (4) 5-Day Magic Your Way Tickets with Park Hopper® Option.
  - v. One (1) Disney Gift Card with a value of \$200.00. Subject to restrictions. The Disney Gift Card can be used at select participating locations at Walt Disney World® Resort, Disneyland® Resort, Disney Cruise Line, Disney store locations in the U.S., Canada, and Puerto Rico, shopDisney.com , DisneyPhotoPass, Adventures by Disney®, Aulani, A Disney Resort & Spa, and Disney's Beach Resorts. It cannot be used toward the purchase of a Disney Vacation Club Membership. Visit DisneyGiftCard.com for complete terms and conditions. Additional restrictions may apply.
  - vi. **The estimated retail value of the vacation package is \$7,496.04.**

NOTE: Items that are not included as part of the winning vacation package(s) are: meals, hotel room service, laundry service, alcoholic beverages, merchandise, souvenirs, etc., local and long distance telephone calls, tips, gratuities, service charges or taxes. All other charges and items not otherwise described above. Winning vacation rules include, but are not limited to: Vacation(s) must be taken between 7/1/2022 and 9/30/2023. Departure date and accommodations are subject to availability; certain restrictions and block-out dates may apply. Selection of airline, hotel, and airline seat location at sole discretion of Station and/or prize provider. Airline regulations apply. The winner and guest must travel on the same itinerary and are responsible for obtaining all required travel documents, including, without limitation, passports for international travel. - d. Winner must confirm acceptance of prize within five (5) days of winning, or risk disqualification and selection of an alternate winner (time permitting) in a random drawing of all remaining eligible entries.
