WBAV Magical Orlando Trip Contest Official Contest Rules

These rules apply to the Magical Orlando Trip Contest ("Contest") conducted by Beasley Media Group, LLC d/b/a WBAV-FM ("Station"). In addition, the General Contest Rules posted at www.v1019.com. apply to this Contest. 1. HOW TO ENTER
