

WBAV Magical Orlando Trip Contest Official Contest Rules

These rules apply to the Magical Orlando Trip Contest (“Contest”) conducted by Beasley Media Group, LLC d/b/a WBAV-FM (“Station”). **In addition, the General Contest Rules posted at www.v1019.com, apply to this Contest. If there is a conflict between the General Contest Rules and the Rules for this Contest, the Rules for this Contest shall control.**

1. HOW TO ENTER

- a. The Contest will begin on Sunday, June 9, 2024 and end on Sunday, July 14, 2024.
- b. To enter online, visit www.v1019.com and follow the links and instructions to enter the Contest and complete and submit the online entry form beginning on June 9, 2024 at 12:00 am Eastern Time (“ET”) and ending at 11:59pm ET on Sunday, July 14, 2024 (“Online Entry Period”). Online entrants are subject to all notices posted online including but not limited to the Station's Privacy Policy. Limit one (1) entry per eligible person per day during the Online Entry Period regardless if entrant has more than one email address. Multiple entrants are not permitted to share the same email address. Entries submitted may not be acknowledged or returned. Proof of submission of an entry shall not be deemed proof of receipt by the Contest administrator.
- c. There will be up to a total of one (1) winner selected in the Contest.

2. ELIGIBILITY RESTRICTIONS

- a. This Contest is open to all Station listeners who are 18 years of age or older as of the date of entry into the Contest, who are legal US residents and reside in North or South Carolina, except where prohibited by law. Winners must possess a valid, government-issued ID and show proof of residency to verify eligibility.

3. PRIZES

- a. Up to one (1) Prize will be awarded. The Prize is being provided by Walt Disney World and consists of a five day/four night Walt Disney World® Resort vacation for four (4), Four (4) round trip coach airfares between the major gateway airport closest to traveler's residence and the Orlando International Airport, One (1) round trip ground transfers between the Orlando International Airport and the Walt Disney World® Resort, one (1) standard room(s) (with a maximum of four (4) persons per room) for four (4) night(s) at a hotel at the Walt Disney World® Resort selected by Disney in its sole discretion; based on availability, and Four (4) 5-day Theme Park Tickets with Park Hopper® Option and a \$300 Disney Gift Card. Total approximate retail value of prize: \$8,478.00.

NOTE: Items that are not included as part of the winning vacation package(s) are: meals,

hotel room service, laundry service, alcoholic beverages, merchandise, souvenirs, etc., local and long distance telephone calls, tips, gratuities, service charges or taxes. All other charges and items not otherwise described above.

Winning vacation rules include, but are not limited to:

- Vacation must be taken before 7/30/2025
- Departure date and accommodations are subject to availability; certain restrictions and block-out dates may apply.
- Vacation is for the winner(s) of the sweepstakes/contest and up to three (3) guests of the winner's choosing.
- Vacation and vacation components may not be sold, traded, transferred, rescheduled to dates not within the fulfillment period set forth above, or refunded. Vacation(s) is/are not redeemable for cash.

Selection of airline, hotel, and airline seat location at sole discretion of Station and/or prize provider. Airline regulations apply. The winner and guest must travel on the same itinerary and are responsible for obtaining all required travel documents, including, without limitation, passports for international travel. Failure to claim prize by the specified time will result in forfeiture of the prize. Potential Prize winner will be notified by phone and/or email promptly following the random drawing.

- c. Entrants need not listen to the Station or be present to win.
- d. Winner must confirm acceptance of prize within forty-eight (48) hours of winning, or risk disqualification and selection of an alternate winner (time permitting) in a random drawing of all remaining eligible entries.
