

**WBAV-FM Charlie Wilson
Contest Rules**

These rules apply to the Charlie Wilson Contest (“Contest”) conducted by Beasley Media Group, LLC d/b/a WBAV-FM (“Station”). **In addition, the General Contest Rules posted at www.v1019.com apply to this Contest. If there is a conflict between the General Contest Rules and the Rules for this Contest, the Rules for this Contest shall control.**

1. HOW TO ENTER

- a. The Contest will begin on Monday, September 23, 2024 and end on Sunday, October 6, 2024.
- b. To enter online, visit www.v1019.com and follow the links and instructions to enter the Contest and complete and submit the online entry form beginning on September 23, 2024 at 12:00 am Eastern Time (“ET”) and ending at 11:59pm ET on October 6, 2024 (“Online Entry Period”). Online entrants are subject to all notices posted online including but not limited to the Station's Privacy Policy. Limit one (1) entry per eligible person per day during the Online Entry Period regardless if entrant has more than one email address. Multiple entrants are not permitted to share the same email address. Entries submitted may not be acknowledged or returned. Proof of submission of an entry shall not be deemed proof of receipt by the Contest administrator.
- c. There will be up to a total of one (1) Grand Prize winner and four (4) Secondary Prize winners selected in the Contest.

2. ELIGIBILITY RESTRICTIONS

- a. This Contest is open to all Station listeners who are 18 years of age or older as of the date of entry into the Contest, who are legal US residents and reside in North or South Carolina, except where prohibited by law. Winners must possess a valid, government-issued ID and show proof of residency to verify eligibility.

3. PRIZES

- a. Up to one (1) Grand Prize will be awarded in the Contest. The Grand Prize is being provided by Harrah's Cherokee Casino Resorts and consists of one night standard hotel accommodations (standard room, double occupancy) at the Harrah's Cherokee Casino Resort checking in on Friday, October 19, 2024 and checking-out on Saturday, October 20, 2024; two (2) tickets to see Charlie Wilson at the Harrah's Cherokee Casino Resort on Friday, October 19, 2024; and one (1) \$100 food and beverage voucher to be used at the Harrah's Cherokee Casino Resort. Approximate Retail Value of the Grand Prize is \$850.

Actual value may vary and any difference between stated value and actual value will not be awarded. Certain restrictions may apply. All other costs not specifically stated herein, including but not limited to those of, taxes, meals, tips and additional ground transportation, baggage fees, hotel room service, laundry service, alcoholic beverages, merchandise, souvenirs, and local and long-distance telephone calls are the responsibility of the winner. If applicable, the winner may be required to present a valid credit card upon hotel check in to cover any incidental expenses incurred during the winner's stay. Winner and guest must abide by all hotel, and venue policies. The winner and guest must sign all required releases prior to booking of any travel. If winner is unwilling or unable to travel on the dates specified, the prize will be forfeited and may be awarded to another winner at Station's sole discretion. All travel is subject to availability and restrictions. If a prize-related event is unable to take place as scheduled, for reasons such as cancellation, preemption, postponement or unavailability, including for weather, or for any reason beyond the control of the Station and prize provider, their sole responsibility to the winner will be to award the remaining available elements of the prize(s) and no substitution or compensation will be provided for the unawarded elements of the prize(s). If winner chooses to take the trip without a guest, s/he will be awarded the prize elements for one person only, and the remainder of the prize will be forfeited without compensation. Winner understands that there are inherent risks involved in travel and that these risks may be present before, during and after the trip.. **Prize winner will receive from Beasley Media Group an IRS Form 1099 (or similar) in the amount of the Prize for the 2024 tax year.**

- b. Up to three (3) Secondary Prizes will be awarded in the Contest. The Secondary Prizes are being provided by Harrah's Cherokee Casino and Resort and each consist of two (2) tickets to see Charlie Wilson at the Harrah's Cherokee Casino and Resort on Friday, October 19, 2024. Approximate Retail Value of the Secondary Prizes is \$150.
- c. The winner will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the prize(s). The prize(s) is awarded as is. Tickets valid only on the date(s) printed on the tickets. Tickets are not refundable or transferable, and may not be substituted or exchanged for cash or credit at any time, nor will tickets be replaced if lost or stolen. Tickets may not be sold to a third party. If a prize-related event is unable to take place as scheduled, for reasons such as cancellation, preemption, postponement or unavailability, including for weather, or for any reason beyond control of the Station and/or prize provider, their sole responsibility to the winner(s) will be to award the remaining available elements of the prize(s) and no substitution or compensation will be provided for the unawarded element(s) of the prize(s). The Station and/or venue, in their sole discretion, reserve the right to deny entry to or to remove the winner(s) and/or guest(s) if either engages in disruptive behavior, does not follow Station and/or venue policy regarding COVID-19 guidelines, or in a manner with intent to annoy, abuse, threaten or harass any other person at the prize-related event. Winner understands that there are inherent risks involved in attending the prize-related event.
- d. All prizes or prize certificates must be claimed as directed by the Station at the time of notification. Prize or prize certificate must be claimed within forty-eight (48) hours of winning. Failure to claim prize by the specified time will result in forfeiture of the prize.

It is the winner's sole responsibility to claim the Prize or prize certificate within the timeline provided in these Official Rules.

4. SELECTION OF WINNERS

- a.** Up to one (1) Grand Prize winner and three (3) Secondary Prize winners will be selected at approximately 8:00am ET on Monday, October 7, 2024 in a Station-conducted random drawing from all eligible online entries received during the Online Entry Period. Potential Grand Prize winner and Secondary Prize winners will be notified by phone and/or email promptly following the random drawing.
- b.** Odds of winning depend on the number of eligible online entries received during the Online Entry Period.
- c.** Entrants need not listen to the Station or be present to win.
- d.** Winner must confirm acceptance of prize within forty-eight (48) hours of winning, or risk disqualification and selection of an alternate winner (time permitting) in a random drawing of all remaining eligible entries.
- e.** Decisions of Station management with respect to the Contest are final.
